I. Identification of the company:

- If the 2012 Company Form has not yet been filled in and sent to the Agency this year or in case of modified circumstances since it was sent (change of ownership/shareholders, new financial year, change of the bank details...), a new company form must be filled in and sent with the corresponding documents.
Any modification that is not notified to the Agency may cause the delay or the cancellation of the financing and contracting of the selected project(s).

II. Information concerning the distribution of the film:

- a Print out of the E-Form
- The acknowledgement of receipts of the E-Form
- The Declaration on the Honour
- The Budget Form
- one copy (complete with annexes and without alterations) of the distribution contract or agreement with the producers and/or sales agent with the hand written statement "*Copy certified as true*" signed by the legal representative of the company (the contract must be signed on the relevant deadline of this Call at the latest).
- In case of a digital release your digital services should be detailed (Digital distribution can be supported as long as it is of a minimum quality (=1,3 k))

III. Information concerning the grouping:

- If you are joining a grouping that has already been selected at a previous session: a letter from the grouping's coordinator acknowledging your participation to the grouping. Please note that it is only possible to join groupings that have been selected under the 2 previous deadlines of the Cinema selective Scheme.

Applications failing to supply the necessary documents may be considered ineligible.
